## Rules and Regulation of International Exhibition of Fisheries and Aquaculture 2017

### Article 1: COMMITMENT

By signing the application form, exhibitors accept the provisions of the rules governing the event.

### Article 2 : ADMISSION

Admission of exhibitors is confirmed by the signature of the entry form duly filled out and completed.

For exhibitors who do not fulfill payment obligations to the organizer, the admission will be denied.

The occupation of a stand may be assigned for one exhibitor. The grouping of several exhibitors on a single stand area is not permitted, except for co-exhibitors who have paid registration fees.

**Article 3 :** The total amount of the participation fees is due to the organizer.

Failure to pay the balance or the rest of the payments to be made on the stipulated date leads, without prior notice, to forfeiture of the right to exhibit. The deposit remains irrevocably due to the organizer.

### Article 4 : PROMOTION

It is forbidden for exhibitors to place stickers, posters or signboards on the site, other than on their own stand.

Exhibitors wishing to undertake commercial and media activities must have a prior authorization from the organizer.

### Article 5 : ALLOCATION OF SITES

5.1- The organizer establishes the layout of the event and makes the allocation of stands in accordance with the exhibition sectors and confirmed admissions. The organizer takes into account as far as possible the exhibitors' choices and the nature of the exhibits.

5.2- In the constitution of lots and the allocation

of sites, the organizer tries to take account of the choices made by exhibitors, the nature and the interest of the items or services they intend to promote.

5.3- Unless otherwise arrangement, registration does not confer any right to the enjoyment of a particular location.

### Article 6 : STANDS INSTALLATION AND CONFORMITY

6.1-The "Technical File," set a time period to the exhibitor to proceed before the opening of the event, to set up his stand there and store products and equipment they need.

6.2- Exhibitors are required to comply with the organizer's instructions concerning the regulation of entry and exit of goods, particularly with regard to the circulation of vehicles within the confines of the event.

6.3- In the stands, it is strictly forbidden to notch or damage in any way whatsoever partitions, floors or ceilings and all equipment provided by the organizer or its contractors.

6.4- It is forbidden to place signboards or advertising signs outside the stands at points other than those reserved for this purpose by the organizer.

6.5- Explosive materials and in general all dangerous or harmful products will not be admitted. The equipment functioning and installation or distribution of objects likely to cause discomfort or danger to other exhibitors or visitors are prohibited.

### Article 7: REGISTRATION FEES

Exhibitors are required to pay to the organizer the registration fees set in the registration form. Registration fees include: integration in the alphabetical list of the Exhibition Catalogue, issuing badges for participants, invitation cards for visitors, the overhead costs of advertising, administrative costs and certificates of

participation .

**Article 8 : PAYMENT TERMS**

Exhibitors will not be allowed to occupy the space before the payment reception by the organizer. The payment schedule is established as follows: 50% on order and 50% no later than 10th october 2017.

**Article 9: INSURANCE**

Although all necessary safety precautions are duly taken during the preparation of the opening period and dismantling period, the organizer can not be held responsible for the safety of whatsoever products brought to the exhibition site. Exhibitors must always ensure that they are fully covered by their insurance policy, both at the level of damage caused to others and their own protection.

9.1- Damage to the presence or operation of equipment exposed or related to the exhibition on the stand will not be covered by the organizer's insurance.

**Article10 : DEGRADATION**

Exhibitors must leave the locations, decors and materials available to them in the condition they would find them. Any deterioration caused by their installations will be evaluated by the technical staff of the organizer and charged to responsible exhibitor.

**Article 11 : CATERING**

The Convention Center of Oran features a restaurant. Exhibitors may apply for all drink, food, buffets, cocktails, etc. orders at the Centre restaurant.

**Article 12 : CANCELLING OR FAILURE TO APPEAR**

In case of withdrawal or non-occupation by the exhibitor of their stand, for any reason, they can not claim any refund.

The amounts paid and/or due partially or totally under the stand rental are due the organizer even if is rented again to another exhibitor.

In case an exhibitor, for whatever reason, does not occupy his stand 24 hours before the exhibition opening, he will be deemed to have resigned. The organizer may make use of the defaulting exhibitor's stand. This one can not claim refund nor compensation even if the stand is allocated to

another exhibitor.

**Article 13: EXHIBITION CATALOGUE**

The organizer will publish a special catalogue of the INTERNATIONAL EXHIBITION OF FISHERIES AND AQUACULTURE 2017. All exhibitors must register on the alphabetical list catalogue of the INTERNATIONAL EXHIBITION OF FISHERIES AND AQUACULTURE 2017.

Once registred, the exhibitor must provise the organizer as soon as possible, with all relevant information regarding the business (trade name, phone number, fax, email, registered office, business areas).

**Article 14 : STANDS REMOVING AND EXHIBITION CLOSING**

The dismantling of stands may be initiated by the exhibitors once the show officially closed.

The evacuation of the stands from merchandise, articles and special decorations, and residual waste materials used to decorate the stands, must be made by the exhibitor within the deadlines and schedules arranged by the organizer.

**Article 15: FINAL PROVISIONS**

The organizer may cancel or postpone the event in case of force majeure related to any new economic, political or social not reasonably foreseeable situation, on the local, national or international scale, beyond the control of the organizer, which makes it impossible to hold or run the event.

**Article 16 : PLACE OF PERFORMANCE AND JURISDICTION**

The place of performance and jurisdiction in respect of all obligations of both parties is Oran. The laws of the People's Democratic Republic of Algeria apply.
